- **Before the course begins**, send per e-mail the **medical certificate for non agonistic activity (MANDATORY)**
- Children have to be able to swim.

MANDATORY CLOTHING

1. Comfortable shoes (like running shoes), rubber slippers, sailing boots or a second pair of shoes that can get wet.
2. T-shirt white or otherwise clear
3. Shorts
4. Bathing suit
5. Towel
6. White Cap or otherwise clear
7. K-way or windproof-jacket
8. Dry clothes: underwear, t-shirt , shorts and shoes
9. If you have your own lifejacket take it with you, otherwise you can use the ones that the Club provides
10. Remember to wear no wet clothes or shoes when you're not doing water activities
11. In the backpack always put a sweater, at the lake you never know!
